WARRANTY DEED

RONALD R. CAOUCETTE of Buxton in the County of York and State of Maine, for consideration paid, grants to ENW APARTMENTS, LLC, a Maine limited liability company, with a mailing address of 174 Narragansett Trail, Buxton, ME 04093, with Warranty Covenants, the following property:

PARCEL 1

A certain lot or parcel of land, with the buildings thereon, situated on the Southwesterly side of Main Street in the City of Biddeford, County of York and State of Maine, bounded and described as follows:

BEGINNING at a spike in an old fence on the Southwesterly side of Main Street at the Northerly corner of land herein conveyed and also at land of owner unknown; thence Southeasterly by Main Street a distance of seventy-four and 93/100 (74.93) feet to an iron pipe driven into the ground at land of one Buda, said last mentioned iron pipe being fifteen and 18/100 (15.18) feet Easterly of the Easterly corner of the granite foundation standing on land herein conveyed and fifty-two and 95/100 (52.95) feet Northerly from the Northerly corner of the brick foundation standing on land of said Buda; thence Southwesterly by land of said Buda and making an included angle of 89 degrees 52' with said Main Street a distance of forty-nine and 76/100 (49.76) feet to a spike driven into the top of a fence post, said spike being fifty-two and 29/100 (52.29) feet Northwesterly of the Westerly corner of the concrete block foundation of Buda's house; thence Southeasterly at right angles with the last described line and by Buda's land a distance of one (1) foot to an iron pipe driven into the ground and land of one Cartier; thence Southwesterly by said Cartier's land and making an included angle of 90 degrees with the last described line a distance of fifty and 24/100 (50.24) feet to an iron pipe driven into the ground at the Westerly corner of Lot No. 14 as shown on a plan of property of Pepperell Mfg. Co. Biddeford, Maine, drawn by R.W. Libby, Eng. Dated May 10, 1926, recorded in the York County Registry of Deeds in Book 10, Page 39; thence Northwesterly by said Lot No. 14 and by Lot No. 13 now owned by Pothier and making an included angle of 90 degrees 07' with the last described line a distance of seventy-five and 35/100 (75.35) feet to an iron pipe driven into the ground at land of said owner unknown; thence Northeasterly by said land and by an old granite wall making an included angle of 90 degrees 07' with the last described line a distance of one hundred (100) feet to the point of beginning.

PARCEL 2

A certain lot or parcel of land with the buildings thereon situated in the City of Biddeford, County of York and State of Maine, on the Southwest side of Main Street, being more particularly described as follows:

BEGINNING at an iron rod set in the North corner of the lot herein described, said iron being Nine and Twenty-one Hundredths (9.21') feet from the corner of the granite foundation of the house situated on said lot and also being Nine and Nineteen Hundredths (9.19') feet from the corner of the granite foundation of the house situated on adjacent lot of land now or formerly of Richard A. Hodgdon and Valerie S. Hodgdon; thence South  $51^{\circ} 48' 06''$  West Ninety-one and No Hundredths (91.00') feet by said Hodgdon land to a corner, said line running Five and Ninety-two Hundredths (5.92') feet from and parallel with the foundation of the house situated on herein described lot, and an iron rod set; thence South  $38^{\circ} 10' 08''$  East, Fifty-two and Sixty-seven Hundredths (52.67') feet to land of Norman M.
